### Submission of Abstracts - Author guidelines

Abstract should report original research in any area of Biochemistry or Molecular Biology which has not been previously published or presented elsewhere. The complete abstract should be submitted in electronic form only, to the following e mail address; [cbslconference@gmail.com](mailto:cbslconference@gmail.com) with the words, **abstract submission** in the subject line. All correspondence regarding the abstract will be with the submitting author.

Membership of the college is not a requirement for submission of abstracts and presentation at the conference. All abstracts submitted according to the following guidelines will be peer evaluated prior to acceptance. Authors may be asked to make amendments to the abstract based on peer review. CBSL reserves the right to edit the abstract prior to publishing. **Abstracts will be accepted between 15<sup>th</sup> January 2023 – 30<sup>th</sup> April 2023.**

#### Formatting:

Entire contents of abstract (including title and authors) should fit within A4 page with 2.54 cm (1 inch) margins all round. No header or footer.

Line spacing 1.5 (18 pt).

Abstract title and author information should be center-justified. Main body of abstract should be justified.

Typeface: Text; Times New Roman 12 point throughout.

**Abstract No.** The first line of the page to carry the words “Abstract No.” right-justified. (Number will be assigned by CBSL)

**Title:** In bold type centered on page, maximum 20 words. Capitalize first word and proper nouns only. Avoid use of abbreviations.

**Authors:** First name or initials and surname. There should be no full stops between initials in the name. Names should be separated by commas. Presenting author<sup>1</sup> (underlined).

\*Corresponding author<sup>2</sup> (asterisk)

**Affiliations:** Italicized. If there is more than one affiliation, should be related by superscript numbers after the name. Author’s affiliation<sup>1</sup>, Author’s affiliation<sup>2</sup>. Authors with the same affiliation should carry the same superscript. If all authors have the same affiliation, no superscript number is required. Corresponding author’s e mail address to be included in the next line.

**Abstract body:** Maximum 300 words. Should begin after leaving a blank line after author affiliations. Should comprise a background, objectives, methods, results, and conclusion.

All units should be as SI units. No tables, figures, or references.

**Acknowledgements:** (if any) should be limited to sources of funding. Eg: Financial assistance by .... Research grant (number).

**Ethical clearance:** It is mandatory to submit the letter of approval by an Ethics Review Committee for all studies conducted on Humans and animals.

**Abstract** (maximum 300 words; to comprise a background, objectives, methods, results, and conclusion. All units should be as SI units. No tables, figures, or references).

**Formatting for entire document:** The entire contents to fit onto a single A4 page size; Margins 2.54 cm (1 inch) all round. Line spacing 1.5 (18 pt). Font Times New Roman, 12 point.
